 several Courses thereof to the mouth of Tindalls Creek
 then up the same variously to the first Station con-
 taining by Estimation One Hundred Acres of Land to
 the same more or less To Have and to hold the
 aforesaid One Hundred Acres of Land with all the
 priviledges and Benefits thereunto belonging Except the
 Quit Rents to his Majesty And I Except the Use of all
 the pine Trees to my self for to make Turpentine with

 teenth October One Thousand seven hundred and Sixty
