 before the Execution and Delivery hereof the Receipt where
 of is hereby Acknowledged the said John Garrutus
 hath Bargained sold Aliened Encroached and Confirm-
 ed and by these presents doth Bargain sell alien Enc-
 roach and Confirm unto the said John Morris his Heirs
 & Assigns for ever a parcel of Land situate lying and
 being in the County and Province aforesaid and on
 the South side of Bay River and on the head Branches
 of Limestone Babbin and proclis Creek beginning at
 a Gum in the Swamp in the line that parts Ben-
 jamin Stukers and said Garrutus Land and runs
 along said line N^o 26 E^t 60 pole to a Holly a corner
 of said Garrutus Patent then along the line of the
 Patent N^o 88 pole to a Gum then along the patent
 line N^o 32 E^t 120 pole to a Bay Tree then S^o 75 E^t 48
 pole to a post in the middle of a Branch then
 up the branch S^o 15 E^t 120 pole and from thence
 to the first Station containing One Hundred and Fifty
 Acres of land and is part of a Patent granted to
 said Garrutus for six hundred and Forty acres bear-
 ing date the fifteenth day of November in the Year
 of our Lord One Thousand Seven hundred and Sixty
 one the said John Morris the said bargained Prem-
 ises to have and to hold to him & his Heirs and
 Assigns for ever and all and singular the premises
 with their and every of their Appurtenances unto the
 said John Morris his Heirs and Assigns to the proper
 use and behuf of the said John Morris his Heirs and
 Assigns and the said John Garrutus his Heirs Executors

and Administrators Dole Bovmont and Grant to and with the said John Morris his Heirs and Assigns that he the said John Morris his Heirs and Assigns the said Bargained premises to enter into without the Let Trouble Hindrance or molestation of any person or persons whatsoever and the said John Morris his Heirs and Assigns the said Bargained premises hath good Right full power and Lawfull Authority to Have Hold Occupy Possess and peaceably Enjoy from all and all Manner of Intrusion whatsoever and the said John Barruthers his Heirs Executors and Administrators the said Bargained premises with their and every of their Appurtenances unto the said John Morris his Heirs and Assigns will warrant and for ever defend against the claim or claims of any person or persons whatsoever In Witness whereof the said John Barruthers hath hereunto set his hand and seal the day and year aforesaid —
