

Deed, as far as will fetch home to first station, to contain fifty Acres of Land and is part of a patent grant to said Carruthers for six hundred & forty Acres bearing date the fifteenth day of November in the Year of our Lord one thousand seven hundred & sixty two the said Moses Morris the said bargained Premises to have & to hold to him, and his heirs & Assigns forever and all & singular the Premises with their & every of their Appurtenances unto the said Moses Morris his heirs & Assigns to the proper use of the said Moses Morris his heirs & Assigns and the said John Morris his heirs Executors and Administrators doth Covenant and grant to and with the said Moses Morris his heirs & Assigns that he the said Moses Morris his heirs & Assigns the said bargained premises to enter unto without the least trouble, hindrance or Molestation of any person or persons whatsoever, and the said Moses Morris his heirs & Assigns the said bargained premises hath good ^{full} power & Lawfull Authority to have occupy possess & enjoy from all manner of Incumbrance whatsoever and the said John Morris his heirs Executors & Administrators the bargained premises with their & every of their appurtenances into the said Moses Morris his heirs and Assigns will warrant and forever defend against the claim or Claims of any person or persons whatsoever.
