Witnesseth that the said Tho K Torrans for & in consideration of ^{the sum of} one hundred dollars to him in hand paid by the said Gideon Heath the receipt whereof is hereby acknowledged Hath given granted bargained sold alienated & confirmed & by these presents doth give grant bargain sell alien & confirm unto the said Gideon Heath his heirs exec^{ts} adm^{rs} & assigns a certain Tract or parcel of land lying & being in the County of Craven & State aforesaid Beginning at a pine on the East side of the Juniper Swamp & runs thence N^o 34 W^o 20 poles to a pine James Newports Corner then with his line N^o 55 W^o 60 poles to a Laurel thence South S^o 44 W^o 151 poles to a pine in Thomas Whitheringtons line thence along his other line S^o 33 W^o 294 poles to his other corner then S^o 55 E 90 poles to a stake then a direct line to the first station Excepting fifty acres of land included in S^o boundaries which the S^o Tho K Torrans have heretofore conveyed to William Watson which leaves a balance of two hundred acres more or less together with the hereditaments & appurtenances thereto belonging unto the said Gideon Heath his heirs & assigns for ever, & the said Tho K Torrans for himself his heirs exec^{ts} adm^{rs} & assigns doth forever warrant & defend the above bargained premises, against the lawful claim of all manner of persons whatever holding or claiming by from or under him them or any of them unto him the said Gideon Heath his heirs & assigns for ever In witness whereof the party hath hereunto put his hand & seal the day & year first above written signed sealed & delivered.





This Indenture made this sixteenth day of October in the year of our Lords one thousand eight hundred and fifteen, Between Saban Morris of the State of North Carolina, and County of Craven of the one part, and Hiram Pollard of the same State, and County aforesaid of the other part. Witnesseth that the said Saban Morris, for and in consideration of the sum of two hundred dollars to him in hand paid by the said by the said Hiram Pollard, Hath bargained, sold aliened, enfeoffed, conveyed

and confirmed, and by these presents, do bargain, sell, alien, enfeoff, convey, and confirm unto the said Hiram Pollard, certain pieces, or parcel of land, situate lying and being in the County of Craven aforesaid, on the North side of New River, and North side of Malls Swamps, Beginning at a Pine near the head of Watery branch, in or near Brigs line, running S. 80 E. 101 Poles to a light wood, stump, near a Meadow, then N. 220 poles to a Pine, in or near John Nelsons line, then N. 77 W. 206 poles to a stake near a small drain, and near Eliager Nelsons corner two Pines, then with a straight line to the beginning, containing two hundred acres, patent bearing date 24th January 1783. References being had there unto will more fully appear of Record, which said piece or parcel of land, the said Laban Morris purchased of the Heirs of Hardy Gattin Esquire deceased, in the year one thousand eight hundred and fourteen, as by deed will appear, bearing date 17th May. To have and to hold to him the said Hiram Pollard, his heirs and assigns forever the above bargained land and premises. Together with all and singular the Hereditaments and appurtenances to the same belonging, or in any wise appertaining to him the said Hiram Pollard his heirs and assigns. And the said Laban Morris for myself, and each of my heirs, doth covenant to and with the said Hiram Pollard, his heirs and assigns to defend unto the said Hiram Pollard the above described tract or parcel of land, against the lawful claim of each of my heirs, and from the further claims of any person, claiming by, from or under me.
