Hundred dollars to him in hand paid by the said Thomas Wadsworth the receipt whereof is hereby acknowledged and myself fully satisfied and paid have given granted bargained and sold and by these presents do grant bargain and sell unto the said Thomas Wadsworth his Heirs executors administrators and assigns forever a certain tract or parcel of land lying and being in the County and State aforesaid and south side of Neuse river and east side of Core Creek beginning at a white oak on the upper side of a branch and lower side of Core Creek running N. 30 W. the reverse of Joseph Leech line until it intersects with Thomas Sprigg's line then with said Sprigg's line South 32 West to the grante branch then the various courses of said branch to the turn of Core Creek then the various courses to the beginning so as to contain all the lands on the lower side of Core Creek and lower side of the grante branch commonly called Muns branch joining the patented lands of Thomas Sprigg containing two hundred and seven acres more or less which said land was patented by George Stringer and part by Robert Taylor and Ebenezer Slade.

To have and to hold the aforesaid two hundred and seven acres of land with the appurtenances and all rights privileged and improvements to the same belonging to him the said Thomas Wadsworth his Heirs and assigns forever and the said John S. Witnesseth that for and in consideration of the sum of Seventy five dollars to us the aforesaid John and Joseph Barruthers in hand paid by the aforesaid Joshua Barraway the receipt whereof is hereby fully acknowledged have given granted bargained and sold and by these presents do give grant bargain and sell to the aforesaid Joshua Barraway his heirs and assigns a certain piece or parcel of land lying and being in County and State aforesaid on the N^o side of Neuse River and head of Browns Creek begining at a Holly in John Ives' line running with Ives' line down the swamp to William Barraway's line then with his lines to Archabald McCotters line then up the other side of the swamp with his line to Joseph Barruthers' line then with his line up the swamp and across with said line to Ives' line and with his line and with his line to the begining containing fifteen acres be the same more or less to him the said Joshua Barraway his heirs and assigns and the aforesaid John Barruthers and Joseph Barruthers as will for themselves as the Heirs of Alexander Barruthers dec'd for ever warrant and defend the aforesaid land and premises to the said Joshua Barraway his heirs and assigns forever In witness whereof we have hereunto set our hands and sealed the day and year above written - signed seal and delivered in presence of
